

## CORPORATE GOVERNANCE STATEMENT OF FITZROY RIVER CORPORATION LIMITED A.C.N. 075 760 655 (ASX: FZR) PROVIDED PURSUANT TO ASX LISTING RULE 4.10.3

This Corporate Governance Statement (CGS) is provided by the Directors of Fitzroy River Corporation Limited A.C.N. 075 760 655 (FZR or the Company) pursuant to ASX Listing Rule 4.10.3 and reports against the ASX Corporate Governance Council's 'Corporate Governance *Principles and Recommendations*' 3<sup>rd</sup> Edition (the Recommendations) including the 8 principles and 29 specific recommendations included therein. This is the sixth time the Company has reported against the 3<sup>rd</sup> Edition of the Recommendations. Commencing from the Company's reporting in conjunction with the 2021 financial year, the Company will report against the 4<sup>th</sup> edition of the Recommendations which come into effect. This CGS was approved by a resolution of the Board of the Company dated 19 October 2020 and is effective as at the same date and is in addition to and supplements the Company's Appendix 4G which is lodged with the ASX together with this CGS.

The Board as a whole recognises that best practice principles assist in its role of overseeing the Company's affairs. Given the size and structure of the Company, the nature of its business activities and the cost of strict and detailed compliance with all the Recommendations, the Board has adopted a range of modified systems, procedures and practices which it considers will enable it to meet the central Principles contained in the Recommendations. The Company's practices are broadly consistent with those set out in the Recommendations and, where they do not correlate with the Recommendations, the Company considers that its adopted practices are appropriate to it.
